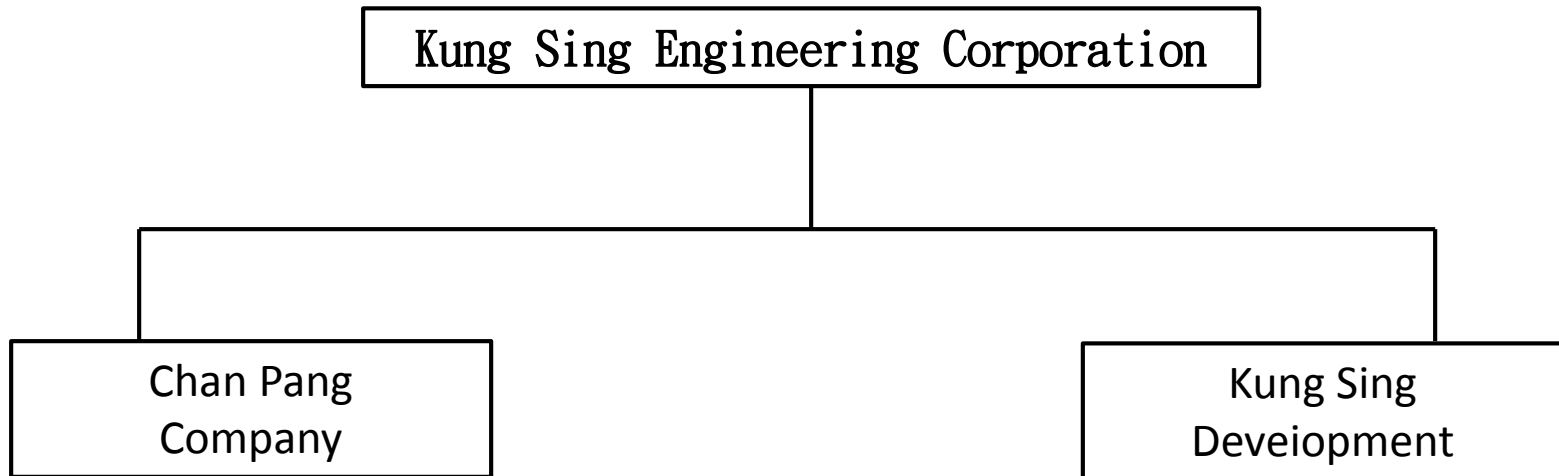

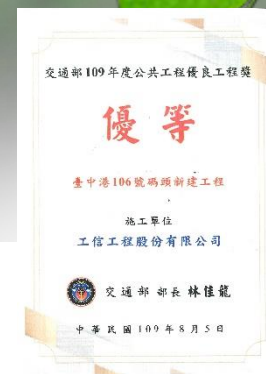
➤ Relationship Organization Chart
